



## Student Code of Conduct 2022-2023

This Student Code of Conduct serves as a supplement to the Community Handbook in order to provide additional information regarding specific violations, interventions, and consequences. It works in tandem with the Community Handbook to provide clarity on policies related to student behavior.

During the first week of school, each grade level will review and discuss this Student Code of Conduct to ensure students and teachers have clear expectations for behavior and understand possible interventions and consequences. Students and families will then sign-off on their having read this Student Code of Conduct as well as the Community Handbook.

When a student is referred for a behavior listed below, the teacher/ administrator will take the following 4 steps:

- 1) Facilitate a private, reflective conversation with the student.
- 2) Make parent contact.
- 3) Determine appropriate interventions and consequences.
- 4) Communicate outcomes and action plans to involved parties.

It is important to note that the administrator may need to pull the student from class in order to discuss the issue. Only administrators have the authority to suspend.

**Defamation and Obscenity**

<p><b>Defamation:</b> Using words or materials that are false and expose a person to hatred, contempt, ridicule, disgust, or an equivalent reaction, or are false and have a tendency to impugn a person’s occupation, business, or office.</p> <p><b>Obscene Materials*:</b> The use or presentation of physical or digital materials that may include, but are not limited to, items that an average person, applying contemporary standards of the school community, would find, taken as a whole, appealing to erotic interests and lacking serious literary, artistic, political, or scientific value. The standard to be used is of the school community, recognizing that students are, as a group, younger and more sensitive than the general adult population.</p> <p><b>Sexting*:</b> Sending sexually explicit messages or photos electronically, primarily between cell phones and other mobile devices. <b>Bullying, Hazing and Intimidation</b>		
<b>Behavior Definitions/Descriptions</b>	<b>Interventions</b>	<b>Consequences</b>
<p><b>Bullying:</b> Engaging in repeated acts, over time, that involve a real or perceived imbalance of power with the more powerful child or group attacking those who are less powerful. Bullying can be physical in form (e.g., pushing, hitting, kicking, spitting, stealing); verbal (e.g., making threats, taunting, teasing, spreading rumors, name-calling); or psychological (e.g., social exclusion spreading rumors, manipulating social relationships).</p> <p><b>Cyber Bullying*:</b> Bullying (see Bullying definition above ) committed via online platforms and mediums.</p> <p><b>Hazing:</b> Any humiliating or dangerous activity expected of a student to belong to a group, regardless of their willingness to participate. The state definition and potential consequences for hazing can be found in <a href="#">Arizona Legislature Chapter 202, House Bill 2322</a>.</p> <p><b>Intimidation:</b> Intentional behavior by a student or group of students that places another student or group of students in fear of harm or personal property. (Intimidation can be manifested emotionally or physically, either directly or indirectly and by use of social media).</p> <p><b>Threat*:</b> Indicating, by word and/or conduct the intent to cause physical injury or serious damage to a person or their property.</p> <p><b>Extortion:</b> Attempting to obtain or obtaining money or property by threat, force, or in return for protection.</p> <p>*Consequences for Improper Use of Technology align with the ASA’s Technology Agreement and/or other behaviors within this Student Code of Conduct. <b>Harassment and Sexual Misconduct</b>		
<b>Behavior Definitions/Descriptions</b>	<b>Interventions</b>	<b>Consequences</b>
<p><b>Harassment:</b> Intentional behavior by a student or group of students that is disturbing or threatening to another student or group of students. Intentional behaviors that characterize harassment include, but are not limited to, stalking, hazing, social exclusion (examples: purposeful isolation, telling someone to exclude others), name-calling, unwanted physical contact and unwelcome verbal or written comments, photographs and graphics. Harassment may be related, but not limited to, race, religions orientation, sexual orientation, gender expression, gender identity, cultural background, economic status, body image, or personal appearance. Harassing behaviors can be direct or indirect and by use of social media.</p> <p><b>Sexual Harassment:</b> Non-consensual conduct of a sexual nature that denies or limits a student's ability to participate in or to receive benefits, services, or opportunities in the school's program. It can include unwelcome sexual advances, requests for sexual favors and other verbal or physical conduct of a sexual nature. Sexual harassment may include, but is not limited to touching, pinching, grabbing, impeding or blocking movement, and lewd gestures, continuing to express sexual interest after being informed that the interest is unwelcome.
