The Committee reviewed the September 2021 Financials. A question was raised by Committee Chair John Snider about the collection of Student Activity fees not being at their budgeted goal. The Committee discussed a software error between ASA's Student Information System (SIS) and online payment systems which caused a posting error that delayed the collection of fees. The error has been resolved and revised numbers in October will reflect the correction. There were no other questions.

Next, the Committee reviewed the status of grants. The school's Education Plus Up Grant was approved; ASA will receive quarterly reimbursements for COVID-related expenses, starting in December 2021, over a period of two years. ASA has also submitted its ESSER III application and budget to the State and is awaiting approval. ASA has prepared an ESSER III budget overview and is ready to present it to community stakeholders for public input, as required by the grant.

Finally, the Committee was updated on the Fiscal Year 2021 Audit. ASA has received a preliminary draft of the Fiscal Year 2021 audit and the Business Office is currently reviewing. The final report to the Board should be available at the November meeting. The Committee reviewed the new procedures required by Laws 2021, Ch.7,§3

The Finance Committee reviewed the October 2021 financials. An update of the forecast was done to reflect changes to Results Based Funding (RBF), the ESSER III Grant and the Education Plus Up (EPU) Grant.

Next, the Committee was made aware that the ESSER III Grant has been approved and it's first reimbursement request for FY22 expenses is being submitted. The proposed ESSER III budget that was provided to the community is still open for public feedback. To date, there has been no feedback regarding the budget, but the Board will need to consider any presented revisions once that window closes. The Education Plus Up (EPU) Grant has been fully approved and the first reimbursement will be completed next month. ASA also received the final allocation for the IDEA Part B Special Education Grant. The school received additional one-time funds from the American Rescue Plan (ARP) for use in the Special Education Department programs.

The FY21 Annual Financial Audit draft was reviewed. The final draft of the audit will be presented at Monday's full Board meeting for approval.

An extension was filed with the IRS for the FY2021 990s. Confirmation of the approved extension has been received by ASA.

Finally, the Committee reviewed the Classroom Site Fund budgeted amounts for teacher stipends.
