David Garcia asked LeahFregulia to review the current enrollment and discuss the decline in 5th and 9th grade enrollment. He requested that Leah present a high level recruiting and retention plan at the next board meeting and provide monthly enrollment dashboard updates along with the number of applications by grade beginning in October.

The Committee discussed the strategic planning notes and observed that most action items are operational in that they address faculty, student, and parent needs. Leah and Principal Elma Džanić Bass will meet to extract operational items from Board level work and present a plan.

Leah shared the date of October 4th to have a mixer with ASU Herberger leadership and faculty to share priorities and envision partnership opportunities.

The Committee then reviewed the board meeting agenda for September 18th and requested Leah provide information about the latest US News High School Ranking so the board could better understand the metrics used. ASA has consistently ranked in the top 20 high schools in Arizona.
