- Annual Fund donations directly support your child's performing arts education, which is **two daily arts classes** (avg. cost \$4,400 per student per year).
- State funding covers** all academic instructional expenses and **the cost of only one arts class (\$2,200)**, resulting in a **funding gap of \$2,000 per student**.
- We ask for a **\$200/month contribution per student** or the best you can toward your child's performing arts education.
- The Annual Fund must **raise \$1 million annually** to sustain its performing arts program for all our students.
